Regular Board Meeting, Tuesday, September 23, 2014

Board President's Recommendation

- 1) Following a public hearing held Tuesday, September 23, 2014, the Board approved a resolution authorizing an un-voted permanent improvement levy (R.C. Section 5705.314, 5705.06, 5705.09). The board levies a 1.3 mill – general – levy (currently 0 mill) for tax collection year 2015 to fund the permanent improvements.

Treasurer's Recommendations

- 1) Waived the reading and approved the minutes of the regular board meeting held August 19, 2014 as presented by the Treasurer.
- 2) Approved the financial report for the period ending August 31, 2014.
- 3) Approved the fiscal year 2015 annual appropriations at the fund level as presented.
- 4) Approved a donation of \$884.20 from the Primary School Public Support Fund (018-9030) to the new Preschool Student Activity Fund (200-9230) to account for fundraising activities from the 2013-2014 school year by the preschool classes, under the supervision of principal, John Toeller.
- 5) Approved Interfund transfer from the Sophomore Class to the Junior/Senior Class.

Superintendent's Recommendations

- 1) Approved agreement with Perry County Transit to transport student(s).
- 2) Approved the service agreement with Ohio School Boards Association to review and revise the Board policy manual.
- 3) Approved the bus routes and bus stops for the 2014-2015 school year.
- 4) Approved to permit district (salary and hourly) employees to work athletic events as gate and ticket takers and to be compensated through the payroll system for the 2014-2015 school year.
- 5) Approved the Crooksville Exempted Village School District Emergency Management Plan.
- 6) Approved a three year agreement with TruGreen Commercial Lawn Services effective dates September 18, 2013 – September 18, 2016 for the Crooksville High School softball field, baseball field, and football practice field.
- 7) Amended motion #2013-035 Administrator's Contract and stipend for Jacqueline Bolyard's 2013-2014 contract – correct quarterly date of July 31, 2014 to May 16, 2014.
- 8) Approved document for the horizontal salary move for licensed teacher in absence of a transcript.
- 9) Awarded the following individuals with a one year teacher's limited supplemental contract for the 2014-2015 school year:
